Note regarding "Signatory Companies": Prior to the creation of the Association, companies were able to "sign" the International Code of Conduct. According to the text of the Code, by signing the Code a company committed to "become certified by and submit to ongoing independent auditing and verification" by the Association. The Association no longer recognizes signatory status: companies that signed the Code but have not applied for Membership are no longer fulfilling their commitments as signatories.
